Terms and Conditions

1. Booking & Deposits

All appointments require a non-refundable deposit to secure the booking.
The remaining balance must be paid on the day of service.
Appointments are confirmed only once the deposit is received.

2. Home Service Policy

The client must provide a clean, safe, and well-lit space suitable for professional beauty services.
Any delays caused by the client (late start, space not ready, interruptions) may affect the service outcome or duration.
TLC Home Service is not responsible for results affected by unsuitable working conditions.

3. No Refund Policy

All services and products are strictly non-refundable.
Once a service has started, it is considered accepted.
Refunds will not be issued for:
Change of mind
Dissatisfaction after the service is completed
Natural shedding, lifting, or wear
Lifestyle factors (gym, swimming, sweating, sleeping habits)
Improper aftercare

4. Adjustments & Fix Policy

Any concerns must be reported within 48 hours of the appointment.
Adjustments are provided only if aftercare instructions were followed.
After 48 hours, all fixes, refills, or repairs will be charged as a new service.

5. Aftercare Responsibility

Proper aftercare is the client's responsibility.
TLC Home Service is not liable for issues caused by:
Picking, pulling, or excessive pressure
Oil-based or alcohol-based products
Heat misuse
Sleeping with wet hair or lashes
Failure to follow provided aftercare instructions

6. Hair Extension Services

All hair extensions are 100% human hair and considered a hygiene product.
Shedding, tangling, or movement is normal and expected.
Hair extensions cannot be returned, exchanged, or refunded once installed.
Regular maintenance is required to avoid damage or discomfort.

7. Nail Services

Nail services have a wear and tear nature and results vary per individual.
Breakage, chipping, or lifting due to daily activities or misuse is not covered.
Nails used as tools void any fix or adjustment.

8. Eyelash Extension Services

Lash retention varies based on natural lashes, aftercare, and lifestyle.
TLC Home Service is not responsible for early shedding due to oil, steam, rubbing, or sleeping habits.
Clients must inform the technician of any sensitivities or previous reactions.

9. Protein / Smoothening Treatments

Results vary depending on hair history, previous chemical treatments, and home care.
TLC Home Service does not guarantee specific results or longevity.
Improper home care, swimming, or heat misuse may reduce results and is not the stylist's responsibility.

10. Health & Disclosure

Clients must disclose all medical conditions, allergies, scalp issues, pregnancy, or sensitivities prior to service.
TLC Home Service is not liable for reactions caused by undisclosed conditions.

11. Late Arrival, Cancellations & No-Shows


Late arrivals over 15 minutes may result in service cancellation or modification.
